Partnership Highlights

CEPF Executive Director visit to Tokyo

In July, CEPF Executive Director, Jorgen Thomsen, went to Tokyo to welcome Mr. Takashi Kihara, as the new CEPF Donor Council Member for the Government of Japan. Mr. Kihara is the new Director, Development Institutions Division in the Ministry of Finance. During this visit Mr. Kihara reiterated their request for CEPF to agree on a vision shared by the CEPF donor partners on the relationship between biodiversity conservation and poverty reduction and to develop metrics to report on CEPF's contribution to poverty reduction.

While in Tokyo, Mr. Thomsen also met with representatives from the Ministry of Environment and the Ministry of Foreign Affairs.

CEPF participates in the Partnership Fair at the Commission on Sustainable Development (CSD) CEPF participated in the Partnership Fair at the Commission on Sustainable Development (CSD) on 23 April 2004 in New York.

The CSD was created in 1992 to ensure follow up and effective monitoring of the implementation of the Rio Earth Summit agreements. During CSD11 (Spring 2003), the commission was restructured and now operates on two-year thematic cycles; the first year discusses the progress made towards sustainable development in relation to the identified thematic cluster and the second year focuses on speeding up implementation and building on lessons learned. The CSD has been designated as the focal point for discussion on partnerships in the context of sustainable development. At the request of the commission and with the understanding that partnerships contribute to the implementation of sustainable development, a Partnership Fair component was added to the Program of Work for CSD12. Registered partnerships were invited to present the progress of their programs to CSD12 participants. Each partnership had 30 minutes to present, followed by a 15-minute question and answer session.

While biodiversity conservation was not the primary focus of CSD12, each thematic cluster is addressed in the context of several crosscutting issues, including poverty eradication and protecting and managing the natural resource base of economic and social development. As a registered partnership with the CSD, CEPF participated in the Partnership Fair component of CSD12 on 23 April 2004 to demonstrate our progress made towards implementing sustainable development through these two crosscutting issues. The CEPF presentation provided an overview of the partnership's objectives, its means of reaching civil society on the ground and its relationship to poverty alleviation. CEPF has demonstrated significant progress towards sustainable development through work with civil society in developing countries. This message was relayed to the Partnership Fair participants.

CEPF's participation in the Commission on Sustainable Development (CSD) Partnership Fair is part of our requirements to fulfill our Type II Partnership status (now called WSSD Partnerships). The Government of Japan contribution to the CEPF is categorized as a WSSD Partnership.

World Bank Mission to Brazil

In March, World Bank colleagues, Warren Evans (Sector Director, Environment Department), Michael Carroll (CEPF Task Manager), Abel Mejia (Sector Manager of Environment Department for Latin America), Garo Batmanian (Senior Environment Specialist for Brazil) spent time in Brazil with Jason Cole (CEPF Grant Director for Brazil) and various grantees learning about CEPF's program in the Atlantic Forest. CEPF has been providing grants in the Atlantic Forest since December 2002 and currently has an active portfolio of 26 grants providing \$5.1 million to civil society groups working to conserve biodiversity. CEPF's niche in the Atlantic Forest hotspot is the opportunity to increase the number of conservation priority areas under protection and management in the two defined corridors through innovative public/private alliances and partnerships. An important element of this niche is the opportunity to complement existing corridor efforts such as the PPG-7.

The trip provided for significant discussion among the visiting Bank team and the CEPF grant director. Key points discussed included:

- How decentralization of CEPF decisionmaking is working in the Atlantic Forest The mission discussed in detail how proposals are reviewed and decided upon, both in the regular CEPF process and the small grant programs.
- Incentives for the creation of private reserves, which is a fundamental component of the CEPF niche for the Atlantic Forest The mission had long discussions about the fact that financial incentives are lacking for creating private reserves, yet there seems to be strong support for them with many landowners agreeing to create reserves on their lands. This is being used as an innovative tool for helping establish connectivity between protected areas, yet further exploration on new policies to provide better incentives is needed.
- Working with the private sector The mission discussed the merits of a CEPF grant to Instituto BioAtlantica for the Establishment of a Network of Private Reserves and Conservation/Recuperation Systems of Forest Fragments in the South of Bahia implementing efforts on the lands of one of the largest pulp producers of Brazil. This is a sensitive debate within the NGO community since the companies involved have for so long been viewed as the enemy to conservation. This debate continues, but it is exciting for CEPF to be participating in the first direct effort to engage such a company in Brazil.
- Collaboration with the local Bank team The mission highlighted that collaboration between CEPF and the local World Bank office is occurring and they discussed how to expand this effort. One agreed method is for the Grant Director to provide regular updates of the projects funded. Also discussed was the idea of having CEPF present a second time to the Bank's periodic "brown bag" type sessions in Brasilia. In addition, there may be opportunities to share lessons learned in the CEPF experience with other Bank-led projects within the Atlantic Forest; for example, presenting how the locally-managed small grant mechanisms work under CEPF.
- General comment about donor communication The mission suggested that future donor reports should highlight more interesting elements in the reports to the donors, highlighting local coordination of the initiative, innovative programs on the ground, links to other large initiatives, key leveraging examples, and major partnerships.

The mission in Brazil provided a solid overview of CEPF's management in the Atlantic Forest portfolio, including highlights focused on decentralized coordination, innovation, and collaboration among key partners, and was a great opportunity to strengthen the relationship between CEPF and the World Bank.

Highlights From The Field

The CEPF global grant portfolio has grown to in excess of \$49 million, up a robust \$13 million from the Summary of Progress presented to the Donor Council in March 2004. To date, our grants have enabled more than 190 nongovernmental organizations (NGOs), community groups and other civil society partners to undertake strategic conservation projects in 13 of Earth's biodiversity hotspots.

This support to civil society has made a significant new partnership and a number of outcomes possible in the field since the last meeting of the Donor Council.

CEPF and the United Nations Foundation agreed to join forces in supporting a conservation action and network program on the Indonesian island of Sumatra that will build local capacity to manage the island's third largest national park and benefit two other important parks too. Together the parks— Bukit Barisan Selatan National Park, Kerinci Seblat and Nunung Leuser—represent the most important blocks of lowland forests on the island. The World Heritage Committee declared the three parks as a single "Tropical Rainforest Heritage of Sumatra" World Heritage Site in June. The program, known as CANOPI, will train local NGOs and individuals in and around Bukit Barisan to monitor and mitigate threats to the park. It will also provide small grants for the groups to implement related projects and will offer training to managers and NGOs working in the other two parks as well.

- Also in Sumatra, long-time CEPF support to an alliance of more than 20 local groups led by WWF played a key role in the Indonesian government's declaration of Tesso Nilo as a national park in July 2004. The new 38,576-hectare Tesso Nilo National Park is a vital piece of 188,000 hectares of natural tropical lowland forest that remain in the Tesso Nilo Forest Complex. The national government also declared Batang Gadis National Park in northern Sumatra—both in follow-up to its public pledge to create 12 new protected areas this year. In the case of Tesso Nilo, the government took advantage of two retired logging concessions. Work is now underway to establish a management board, including community representatives, to devise and implement a management plan. With CEPF support, WWF also helped establish the Tesso Nilo Community Forum, bringing together all 23 communities surrounding the greater Tesso Nilo Forest Complex. The communities work together to protect the forest and deter potential illegal loggers by creating alternative sustainable income sources from nontimber forest products, such as production of wild honey.
- The CEPF-supported publication of a new action plan for the conservation of West African chimpanzees proved to be a needed springboard for increasing momentum, networking and donor commitments in the Guinean Forests of West Africa Hotspot. The Regional Action Plan for the Conservation of Chimpanzees in West Africa confirms that chimpanzees in the West African region are in serious decline and details a strategy for protecting 80 percent of those surviving. It is the result of a meeting of 72 experts in Abidjan, Cóte d'Ivoire. New commitments include a \$226,780 investment by the U.S. Fish & Wildlife Service and initiatives by several zoos. In March 2004, the United States Agency for International Development Mission to Guinea and Sierra Leone also issued an official Annual Program Statement calling for potential partners to submit proposals to carry out activities in support of its Chimpanzee Conservation and Sensitization Activity in the two countries. The program expects to award a total of \$1 million. Local populations of chimpanzees and humans both stand to benefit. Deforestation is a principal driver of chimpanzee declines in the hotspot, and scientists have shown that it has far-reaching consequences for human populations as well. Deforestation in West Africa has led to decreased rainfall, causing a desertification process that, combined with recent growth in human populations in the region, could bring about resource shortages that could be catastrophic. The degradation of natural resources has also been linked to poverty and civil conflict in the region.
- In the Tropical Andes Hotspot, CEPF support enabled the Amazon Conservation Association (ACA) to assist 80 pioneering Brazil nut producers—known as castañeros—in ensuring the continuity of their livelihood, which in turn depends on healthy forests. With assistance from ACA, each of the castañeros in the Peruvian state of Madre de Dios mapped their traditional area of land tenure, developed a management plan and won a 40-year concession from the Instituto Nacional de Recursos Naturales, which oversees natural resource management in the country. The results are no small feat in Madre de Dios, where conservation has at times been viewed as taking away access to resources and where land tenure is far from straightforward. It is also an imperative for the thousands of castañeros in the region. Recent national forestry legislation requires castañeros to develop formal management plans, complete with maps, for their concessions, which could otherwise be granted to more intensive, extractive industries.

Increasing Communication with Grantees, Donor Partners and the Conservation Community CEPF continued to enhance its communications efforts to promote and help advance its mission, while

expanding information sharing between grantees. One of the major communications aims is to demonstrate and share progress and lessons learned.

- Our local coordination teams and partners helped bring together hundreds of civil society organizations to share secrets of success for maximizing conservation in the hotspots. Each of the conferences that took place in China, Costa Rica, Peru and South Africa aimed to help the groups we support and their partners build on one another's successes, avoid duplication of effort and learn and share best practices—all fundamental tenets of our strategic approach.
 - o In the Mesoamerica Hotspot, 36 groups receiving CEPF support participated in the "Conservation Dialogues for Projects in the Southern Mesoamerican Corridor" hosted by the Rainforest Alliance

in March. The meeting was a key output of a grant to the Rainforest Alliance to advance information sharing in Neotropical hotspots, particularly through expansion of the Eco-Index site, <u>www.eco-index.org</u>.

- Our grantee partners gathered in Lima, Peru in May to review strategy, prioritize key areas for further action and share experiences in their work to safeguard the Vilcabamba-Amboró conservation corridor in the Tropical Andes Hotspot. In addition to grantees, representatives from Peru's Instituto Nacional de Recursos Naturales and Bolivia's El Servicio Nacional de Areas Protegidas as well as park guards from protected areas participated.
- o In June, more than 260 people gathered for the Cape Action for People and the Environment (C.A.P.E.) first partners' conference. Entitled "Innovating Conservation," it brought together partner organizations, government agencies and donors to review progress, share lessons learned and plan for the next five years of implementation in the Cape Floristic Region Hotspot.
- o Also in June, a "Sharing, Cooperation and Scaling Up" meeting organized by Conservation International's China Program drew together for the first time civil society groups we support in the Mountains of Southwest China Hotspot.
- Our newly created local coordination teams in the Caucasus Hotspot and the Eastern Arc Mountains and Coastal Forests of Tanzania and Kenya Hotspot publicly launched the CEPF ecosystem profiles for these two regions in May and June, respectively. Both launches brought a range of stakeholders together to learn how they can help implement and benefit from the investment strategies, and resulted in prominent coverage in the local media, including coverage by local media and the Reuters and Inter Press news services in the Caucasus and a half-page Q & A in the East African newspaper with the CEPF communications director in the Eastern Arc and Coastal Forests hotspot. The Caucasus launch also included the first meeting of a new high-level advisory council composed of governmental and nongovernmental representatives from each of the six countries to help conserve the rich natural resources of the region. Support for the Regional Council for Biodiversity Conservation and Sustainable Use in the Caucasus is a key component of a new regional approach to coordinate CEPF investments in the hotspot and ensure maximum impact. In East Africa, the coordination team—the International Centre of Insect Physiology and Ecology, the Tanzania Forest Conservation Group, the WWF-Eastern Africa Program Office and local BirdLife partners NatureKenya and the Wildlife Conservation Society of Tanzania-held consultative meetings with more than 70 community-based groups and other partners as part of the launch activities.
- The CEPF Web site, <u>www.cepf.net</u>, continues to grow as a valuable resource for CEPF grantees and others, with an average of 1,299 visitors a day from more than 100 countries. In July, also CEPF launched a significantly expanded online Resource Center to consolidate and enable visitors to more easily locate the many documents and other resources available on the site. The center offers four special sections:
- o <u>Partner Gateway</u>: A gateway to the CEPF donor partners and more than 100 CEPF grantee partners with Web sites.
- <u>Publications</u>: A library bringing together all CEPF publications available online, including annual reports, ecosystem profiles and final project completion reports. In FY 2004 (July 2003-June 2004), visitors to the site downloaded 264,722 copies of these documents, including 20,490 final project completion reports detailing results and lessons learned by project leaders.
- <u>Related Programs</u>: Summaries of CEPF small grants programs managed by local organizations, CEPFsupported conservation funds and other related resources. To date, the small grants programs have provided support to more than 200 additional local groups and individuals in the Atlantic Forest, Cape Floristic Region, Madagascar and Philippines hotspots.
- o <u>E-News Subscribe</u>: An easy-to-complete, online subscription form for our newsletter. Subscribers to the newsletter now number more than 1,200.

Taking stock – update on monitoring and evaluation

In early March 2004 CEPF conducted its third portfolio review. From March 13–31 the CEPF monitoring and evaluation team, which included an external consultant, traveled to South Africa to conduct a review of the Cape Floristic Region. The report has been finalized and will be shared at the next Working Group

meeting on October 14, 2004. Additionally, the Madagascar and Tropical Andes reviews have been finalized and are being shared along with the Cape Floristic portfolio review during this meeting. The three completed reviews and review summaries are enclosed at the end of this section for your information.

As with the ecosystem profiles, the portfolio review process will continue to benefit in richness and depth from lessons learned and integrated from previous reviews. CEPF looks forward to discussing the portfolio review process with the Working Group to further define the process and to ensure that we are maximizing our ability to capture the impact and lessons from CEPF portfolios. Following the Working Group meeting and the Donor Council meeting CEPF will circulate a summary document outlining how the current process will evolve based on the first three reviews. As part of this update CEPF will also provide a schedule of the next portfolio review.

Looking forward, the World Bank is currently planning a CEPF Supervision meeting in Sumatra. This trip, scheduled for mid-November, 2004, will visit CEPF projects in the Sundaland portfolio and will provide an opportunity for CEPF and the World Bank to discuss CEPF implementation on the ground.

Update on the pipeline Ecosystem Profiles

CEPF has prepared ecosystem profile for the Indo-Burma (Indochina and Eastern Himalayas), Polynesia/Micronesia and Western Ghats and Sri Lanka). In accordance with the Memorandum of Understanding, each profile was initially submitted to the CEPF partners 45 days prior to the second meeting of the Donor Council. The attached profiles have since been revised to incorporate additional comments and information received from CEPF partners and peer review contributors. Status of the profiles is as follows:

- 1. The CEPF Donor Council authorized CEPF to begin preparing Cycle 4 ecosystem profiles in June 2002. To date, the Caucasus, Eastern Arc Mountains and Northern Mesoamerica profiles have been approved.
- 2. First drafts of the ecosystem profiles were provided to the Working Group on 19 November 2004.
- 3. On 2 December 2004, CEPF convened a Working Group Meeting with representatives from Conservation International (CI), the Global Environmental Facility (GEF), MacArthur Foundation, World Bank, BirdLife International, World Wildlife Fund, South Pacific Regional Environment Programme (SPREP), Ashoka Trust for Research and Environment (ATREE) and Ministry of Environment, Sri Lanka to present and discuss each of the three new ecosystem profiles. Issues and observations discussed during and subsequent to this meeting were incorporated into new drafts of the ecosystem profiles. Additional in-region consultations were held and their input has been integrated into these new draft ecosystem profiles.
- 4. CEPF submitted revised drafts of the ecosystem profiles on 7 September 2004 to the working group. Kathy MacKinnon, Tony Whitten and David Hulse were consulted on any outstanding technical points in the ecosystem profiles because of their regional expertise and provided comments. Comments from this final review period and any comments discussed at the 14 October 2004 Working Group meeting will be incorporated into the ecosystem profiles following the Working Group meeting.
- 5. Revised drafts of the profiles will be shared based on the conclusions and recommendations emerging from the discussion on options for funding the pipeline profiles.
- 6. GEF Focal Point endorsement has been secured for Sri Lanka. The ecosystem profiles are in the process of being considered by GEF focal points in Cambodia, Thailand, Vietnam, Laos P.D.R, China, India, Nepal, Bhutan, and the CEPF eligible countries in the Polynesia/Micronesia hotspot.

Ecology of Cave-Dwelling Invertebrates in the Atlantic Forest

Understand the richness, diversity, endemism and distribution of cave-dwelling invertebrate fauna within the Central and Serra do Mar Corridors of the Atlantic Forest remnants. The study will also provide information of the general state of conservation in the surrounding areas, allowing for the development of appropriate regulations for adequate management of the areas. Funding: \$10,000 Grant Term: 10/04 - 8/06 Grantee: Fundação de Desenvolvimento da Pesquisa / Departamento de Biologia Geral - UFMG

Study of Wildlife Animal Traffic in the Atlantic Forest and Its Implications for Conservation.

Consolidate information regarding illegal wildlife trade with the aim of gathering enough knowledge to sufficiently analyze the extent of illegal traffic in the Central and Serra do Mar corridors of the Atlantic Forest. Included will be the development of instruments for measuring the efficiency and effectiveness of conservation strategies in the region.

Funding: \$174,829 Grant Term: 10/04 - 8/06 Grantee: Rede Nacional de Combate ao Tráfico de Animais Silvestres

Biodiversity Conservation of the Restingas in the State of Rio de Janeiro, Brazil

Carry out a study of the state of conservation of the Restingas along the coast of Rio de Janeiro State with the objective of identifying areas for increasing the protected areas system within the region. Funding: \$14,537 Grant Term: 9/04 - 11/06 Grantee: Instituto de Pesquisas e Conservação da Biodiversidade dos Biomas Brasileiros

Recuperation of the Atlantic Forest in the Watershed of Rio Caraiva

Implement sustainable systems of environmental restoration and the collective management of the landscape by the citizens of the Carava River Watershed on the Discovery Coast. Funding: \$194,267 Grant Term: 9/04 - 8/06 Grantee: Instituto Cidade

Socio-Environmental Restoration of the Atlantic Forest of Minas Grerais, Brazil - Education, **Research and**

Environmental Restoration

Increase the forested areas in the region and promote sustainable use of natural resources through community participation, environmental education and the introduction of new techniques for reforestation. Activities include the development of a monitoring program for environmental indicators in the private reserve RPPN Fazenda Bulcão.

Funding: \$159,822

Grant Term: 8/04 - 7/06 Grantee: Instituto Terra

Biodiversity Conservation and Management in the Watershed of the Sao Joao River

Develop integrated management plans among the various protected areas in the watershed of the Sao Joao River to help ensure protection of threatened species and their habitats. Funding: \$180,000 Grant Term: 4/04 - 12/05 Grantee: Associação Mico-Leão-Dourado

Agroforestry Systems in Southern Bahia: Economic & Conservation Potential of the Atlantic Forest

Carry out a diagnostic of agroforestry systems in the mico-region of Valena (Southern Bahia), working directly with communities and the Agronomy School of the Universidade Federal da Bahia to determine what systems are yielding the best results for conservation and productivity. These results will be disseminated with the hopes of influencing public policy in terms of the region's agrarian development plans.

Funding: \$100,000 Grant Term: 2/04 - 12/04 Grantee: Sociedade de Estudos dos Ecossistemas e Desenvolvimento Sustentável da Bahia

<u>Strategic Direction 2: Improve management of existing and future public protected areas through</u> <u>targeted civil society efforts</u>

Biodiversity Corridor of the Costa do Cacau

Develop and implement an integrated set of actions including agroforestry extension, landscape planning, public policy and environmental awareness compatible with the concept of biological corridors with the long-term objective of creating a mosaic of protected areas and diversified economic activities able to support and maintain biodiversity in the Costa do Cacau, Southern Bahia. Funding: \$250,000 Grant Term: 8/04 - 12/05

Grantee: Instituto de Estudos Sócio-Ambientais do Sul da Bahia

Protecting and Restoring the Três Picos Buffer Zone: A Corridor Approach to Conserving Forest-Based Services and Biodiversity

As a strategy to restore and protect landscape connectivity within the corridor, catalyze forest protection and sustainable land-use management by private land users and community-based organizations in the areas surrounding the Tres Picos State Park. Funding: \$175,476

Grant Term: 8/04 - 7/06 Grantee: Instituto Rede Brasileira Agroflorestal

Ecological Corridor of the South of Minas

Develop and implement the Serra do Mar Corridor concept within Minas Gerais State; assist the management of existing protected areas, create new protected areas (both public and private), train in sustainable use practices and disseminate information across the region. Funding: \$225,270 Grant Term: 5/04 - 4/06 Grantee: Valor Natural

Cape Floristic Region

<u>Strategic Direction 1: Support civil society involvement in the establishment of protected areas and</u> <u>management plans in CFR biodiversity corridors</u>

Van der Kempskloof/Parsonsvlei Management Plan

Develop a management plan for the sustainable use of the Van der Kempskloof/ Parsonsvlei area of the

Eastern Cape Province in South Africa that will inform the development of a community conservation project at Bethelsdorp in the Nelson Mandela Metropole. Funding for the development phase of the community conservation project, which will include a plan and implementation strategy, has already been secured from The Table Mountain Fund. Funding: \$10,000

Grant Term: 8/04 - 1/05

Grantee: Wildlife and Environment Society of South Africa: Eastern Province Region

Effective Conservation Of Amphibians And Reptiles in the Greater Cederberg Biodiversity Corridor

Collate, analyze, interpret and disseminate data on the amphibians and reptiles of the proposed Cederberg Mega-reserve and western corridor in order to provide strategic input into design and management plans for the reserve, as well as build capacity within civil society in the region to enhance visitor experience. Funding: \$69,435 Grant Term: 1/04 - 12/06 Grantee: University of Stellenbosch

<u>Strategic Direction 2: Promote innovative private sector and community involvement in conservation</u> <u>in landscapes surrounding CFR biodiversity corridors</u>

Turning Duineveld Eco-Threat Into Profitable Employment: Phase 1 - Development of a Business Plan

Address threats to biodiversity by exploring means to remove alien species and increase employment opportunities in the Cape Floristic Region through a firewood-cutting scheme. Focus efforts in this first phase by preparing a business plan and action plan for the rural coastal area from Gouritsmond to Jongensfontein in the southern region.

Funding: \$1,967 Grant Term: 7/04 - 9/04 Grantee: Duineveld Coastal Association

Mainstreaming Biodiversity on the Cape Flats: Building Good Practice in Sustainable Management

Achieve good practice in sustainable management of sites in the City of Cape Town. It will first achieve this at four pilot sites - the Edith Stephens Wetland Park, Harmony Flats Nature Reserve, Macassar Dunes and Wolfgat Nature Reserve - selected for their diversity of vegetation type as well as their location in the midst of poor black townships.

Lessons learned at these pilot sites will be shared broadly, and the project seeks to develop and initiate the implementation of a strategy to roll out good practice to the rest of the City's biodiversity network that ensures connectivity between sites and links them within catchments and along coastlines.

Funding: \$375,000 Grant Term: 10/03 - 6/07 Grantee: National Botanical Institute

<u>Strategic Direction 3: Support civil society efforts to create an institutional environment that enables</u> <u>effective conservation action</u>

Ensuring an Effective Role for the Southern Cape Herbarium and Garden Route Botanical Garden in Conservation in the Southern Cape, South Africa

The aim is to help key stakeholders understand and avoid the negative effects of forest conversion on the provincial economy.

Conservation of the Sumatran Orangutan in the Northern Sumatra Corridor

Continue mobile outreach unit to raise local awareness of the orangutan's conservation needs, further develop forest walk and educational program at Sibolangit Environmental Interpretation Center and create an urgent action plan for conserving wild orangutans in the Northern Sumatra corridor. Funding: \$300,000

Grant Term: 12/03 - 11/05 Grantee: Conservation International

Strategic Direction 2: Empower civil society to organize in favor of conserving biodiversity

Save The Tiger Fund

Award small- and medium-sized grants to partners working to save Asia's wild tigers, tiger prey species and tiger habitats and/or to address the threat posed to tigers by illegal wildlife trade. Funding: \$500,000 Grant Term: 1/04 - 12/06 Grantee: National Fish and Wildlife Foundation *This is a multiregional project covering two hotspots; the total grant amount is \$1,000,000.

<u>Strategic Direction 3: Build alliances among conservation-minded groups in civil society and the private sector</u>

Asia Wildlife Trade Strategy Planning

Undertake consultations with Save The Tiger Fund, WildAid and CEPF representatives regarding an Asiawide strategy to more effectively address the threat of wildlife trade to biodiversity conservation. Funding: \$5,302 Grant Term: 1/04 - 3/04 Grantee: TRAFFIC International *This is a multiregional project covering two hotspots; the total grant amount is \$10,604.

Creation and Management of the Tesso Nilo Protected Area as a Centerpiece of Sumatra's Tesso Nilo Bukit/Tigapuluh Conservation Corridor

Encourage federal and provincial governments to designate Tesso Nilo, a last stronghold of Sumatra's fastdisappearing lowland forest, as a protected area and help to put in place a protected area management system endorsed and run by local stakeholders.

Funding: \$994,972 Grant Term: 1/04 - 12/05 Grantee: WWF Indonesia

The Philippines

Strategic Direction 1: Improve linkage between conservation investments to multiply and scale up benefits on a corridor scale in Sierra Madre, Eastern Mindanao and Palawan

Defining and Monitoring Conservation Outcomes for the Philippines

Support the conservation of biodiversity in Eastern Mindanao, Sierra Madre and Palawan by providing a corridor conservation framework for other CEPF grantees that will maximize conservation investment in the creation of new and management of existing protected areas and the management of appropriate interstitial areas for biodiversity Funding: \$382,336 Grant Term: 7/04 - 6/05 Grantee: Conservation International

Creating a New Protected Area for the Mantalingahan Range Forests of Palawan

Carry out biodiversity surveys, help build local government's GIS capacity and refine stakeholders' strategy in ensuring the largest remaining forest left on Palawan is declared a protected area. Funding: \$77,748 Grant Term: 3/04 - 8/04 Grantee: Conservation International

Strategic Direction 3: Build capacity of civil society to advocate for better corridor and protected area management and against development harmful to conservation

Participatory Biodiversity Assessment and Conservation of Mt. Hamiguitan Range, Davao Oriental and Its Environs for Development

Inventory and conserve the endemic, endangered and economically important flora and fauna in Hamiguitan Range and its environs by involving the local community in southeastern Mindanao. This project will provide data to validate the Protected Area Suitability Assessment results for Hamiguitan Range as a proposed protected area.

Mt Irid-Mt Agilo Proposed Protected Area Advocacy Project

Establish a permanent Irid-Angilo protected area and strengthen the awareness of the major stakeholders in the southern portion of the Sierra Madre biodiversity conservation corridor. Educational campaigns and environmental advocacy will be used to further encourage the major stakeholders to participate in efforts to conserve the corridor.

Building Partnerships for Sustainable Management of Critical Watersheds in the Sierra Madre's Palali-Mamparang Mountains

Build capacity of local communities and government officials to call for and implement better forest corridor and watershed management as well as safeguards against development harmful to conservation. Funding: \$9,992

Grant Term: 3/04 - 6/04 Grantee: Friends of the Environment for Development and Sustainability, Inc.

<u>Strategic Direction 4: Establish an emergency response mechanism to help save Critically</u> <u>Endangered species</u>

Enlarged Scales: Strengthening Philippine Crocodile Conservation in the Sierra Madre Corridor

Create recovery plan for the Philippine crocodile (Crocodylus mindorensis) that will serve as a basis for well-coordinated crocodile conservation actions by all stakeholders in the Sierra Madre corridor. Funding: \$13,765 Grant Term: 8/04 - 7/05 Grantee: Mabuwaya Foundation Inc.

Collaborative Work Plan for the Newly Formed Alliance for Research and Conservation of the Philippine

This meeting is a second in follow up to CEPF's workshop on the same subject in September 2003 and will prepare an interim species conservation plan as well as a research plan. Proposals from alliance members should be ready for submission to CEPF immediately afterward. Funding: \$4,103 Grant Term: 2/04 - 2/04 Grantee: Philippine Eagle Conservation Program Foundation, Inc.

Tropical Andes

<u>Strategic Direction 6: Establish an Electronic Information Exchange and Coordinated Information</u> <u>and Data Gathering Mechanism</u>

Implementing Basic Infrastructure for Local Area Networks (LAN), Internal Telephone Communications and a WAN Network Between the National Herbarium of Bolivia and the Bolivian Fauna Collection

Install a computer and telephone network connecting the National Herbarium of Bolivia and the Bolivian Fauna Collection as part of the first phase in a larger effort to interconnect all of the branches of the Instituto de Ecología.

Funding: \$9,831 Grant Term: 6/04 - 12/04 Grantee: Fundación para el Desarrollo de la Ecología

The Vilcabamba-Amboró Corridor Biodiversity Information Management System: A Collaborative Internet Resource for Scientists, Educators and Conservation Managers

Create a mechanism for information sharing across the Vilcabamba-Amboró corridor, making relevant information available on projects, activities and monitoring indicators for biodiversity conservation. The project will also help build capacity of the organizations involved and help build alliances among all those working in the corridor.

Funding: \$196,192

Grant Term: 1/04 - 12/06

Grantee: Asociación Peruana para la Conservación de la Naturaleza (\$50,059), Fundación Amigos de la Naturaleza (\$46,463), Fundación para el Desarrollo Agrario (\$49,670), Fundación San Marcos para el Desarrollo de la Ciencia y la Cultura (\$50,000)

Report on CEPF Financial Summary and Fifth Spending Plan (July 2004 – June 2005)

As required by the Memorandum of Understanding, CEPF is required to present the Donor Council with an annual report against each annually approved spending plan.

In order to adhere to this requirement, the Fifth CEPF Spending Plan and the report against the Fourth CEPF Spending Plan will be circulated for approval electronically, following the Seventh Meeting of the CEPF Donor Council.
