Conservation International is issuing a Call for Proposals (CFP) on behalf of the Critical Ecosystem Partnership Fund for **migration of all content, functionality, integrations and design of the cepf.net website currently running on Drupal 7 to the Craft content management system as well as for ongoing maintenance and support of the website after migration**. The following call for proposals contains the necessary information for interested offerors.

Cepf.net is the website for the Critical Ecosystem Partnership Fund (CEPF), a joint initiative of l'Agence Française de Développement, Conservation International, the European Union, Fondation Hans Wilsdorf, the Global Environment Facility, the Government of Japan and the World Bank. It is administered by Conservation International.

CEPF empowers civil society—nongovernmental organizations, Indigenous groups, academic institutions and private enterprises—to protect the world's biodiversity hotspots and help communities thrive. We do this through grants for conservation, organizational strengthening and sustainable development.

## **Section 1. Instructions and General Guidance**

### **1.1 Introduction**

Conservation International (CI), the Contracting Entity, on behalf of the Critical Ecosystem Partnership Fund, is soliciting offers from offeror firms to submit proposals to carry out **migration of all content, functionality, integrations and design of the cepf.net website to the Craft content management system as well as for ongoing maintenance and support of the website after migration.**

#### **BACKGROUND:**

The Critical Ecosystem Partnership Fund (CEPF) was founded in 2000 as a joint initiative of l'Agence Française de Développement, Conservation International, the European Union, the Global Environment Facility, the Government of Japan and the World Bank to address the growing threats to biodiversity by empowering civil society in developing countries and transitional economies to protect the world's biodiversity hotspots—some of Earth's most biologically rich yet threatened terrestrial ecosystems.

The cepf.net website is used to communicate CEPF's geographic and programmatic scope of work; announce funding opportunities to potential grantees around the world, many of whom connect from remote locations with low connectivity; communicate instructions and strategies for applying; provide a hub of learning resources for grantees and others; and to articulate CEPF's impact at a global level and the project level, publishing descriptive information, associated reports and resources from each of 3,000 projects funded. The site also includes information about the CEPF secretariat team, regional implementation teams, donor council and an archive of related governing documents.

#### **OBJECTIVES:**

The objectives for this contract are to:

- Migrate cepf.net all content, functionality, integrations and current design from Drupal 7 to Craft CMS, and
- To provide post-implementation maintenance and support services for the CEPF website.

#### **cepf.net CMS Components and System Migration Requirements:**

cepf.net is currently running on Drupal 7. Content managers create and update pages through a set of predefined modules or sets of modules customized to the current site design. The CEPF team, CI technical team and a consultant recently evaluated content management systems and selected Craft CMS to replace Drupal based on its ability to maintain or improve current functionality and the added benefit that the CI internal technical staff has experience supporting Craft CMS for the Conservation.org website.

This project envisions a transition of the content management system from Drupal 7 to Craft CMS with no change to the site design and minimal disruption to the availability of the live site. In addition to the core components and requirements listed

below, the previous consultation included a discovery process yielding a requirements document including a representative list of top-level site pages and page templates and User Stories, see **Annex 3**.

### **Technical Infrastructure**

- cepf.net will provide two environments: production and staging, hosted on Amazon Web Services. A cloud-based managed AWS infrastructure (such as S3, Cloudfront, RDS, Elastic Load Balancer, etc.) should be included in the technical infrastructure plan for the replacement with a cost-effective, reliable and scalable structure that will efficiently accommodate traffic and resource consumption increases.

### **Global Access and Accessibility**

- Global availability is required, so the infrastructure must support scalability and be optimized for fast-edge delivery. Many of the grantees accessing cepf.net are in remote areas with low bandwidth.
- The website must conform to Web Content Accessibility Guidelines (WCAG 2.2) at minimum.

### **Languages and Translation**

- cepf.net is accessed in and supports many languages through a combination of automated and manual translations, including through GTranslate.
- The new site should support multiple languages in the CMS with the ability to use automatic translation from Google when custom translations are not available.
- The new site should support multiple languages in the asset management system.

### **Design**

- Content managers create new pages from predefined, flexible modules or sets of modules customized to the site design, which is not being changed at this time.
- A commensurate level of customized and pre-configured modules shall be delivered as part of the project to allow content managers to easily populate and maintain the site without technical assistance.

### **Scale/Size of Site Contents to Be Migrated**

- The site currently has approximately:
  - 10 top-level landing pages.
  - 37 "Hotspot" pages which contain interactive maps.
  - 465 basic pages.
  - 3,000 grantee project pages which are populated by a combination of an integration with Salesforce and locally stored data and resource links.
  - 282 "story" pages.
  - 7,000 files/resources which are managed centrally and tagged for use in/to be accessed from other pages and modules.

### **Salesforce Gateway Integration**

- The grantee project pages are populated using a data endpoint which relies on Salesforce as a data source. Referred to here as "Salesforce Gateway,"

such endpoint contains the base data that composes the project pages. Complementary data, such as file attachments, should be manually related to the entry using Craft CMS admin interfaces. The integration must run multiple times in a day in order to identify new entries, updates and deletion, as well as creating, updating and removing project pages.

#### **Newsletter Registration**

- Site visitors can subscribe to the CEPF newsletter through a form integrated with Constant Contact.

#### **Interactive Maps**

- Users can interact with maps based on pre-defined and standardized geojson shape files.

#### **URLs**

- Where possible, URLs for pages and resources/assets should persist. A redirect strategy should be provided when not possible.

#### **Search and Filtering**

- The existing search and filtering functionality on the site should be maintained in the new site.

#### **Users**

- There are two user roles: Administrator and Content Editor
- There are currently five active end-user accounts (3 Admin and 2 Content Editors) plus additional active technical support staff user accounts.

#### **Maintenance and Support**

In addition to the system and content migration, CEPF requires a vendor to supply ongoing support and maintenance of [cepf.net](http://cepf.net). The vendor will be responsible for the technical maintenance of the environment, including monitoring server performance, ensuring proper backup protocols are being followed, and identifying and applying any security updates that are needed to the platform.

In addition, the vendor will fix bugs and development enhancements as identified and prioritized by CEPF. As necessary, the vendor may be requested to provide design and user experience recommendations. As this work is being performed under the contract, the vendor will provide the project management framework to implement the fixes and enhancements, properly track and manage a centralized code repository, and provide training to CEPF staff as needed. Additionally, in the event of unexpected downtime or issues on [cepf.net](http://cepf.net), the vendor would be available to troubleshoot and fix any emergency issues.

### **1.2 Offer Deadline**

Offers must be received no later than **5 p.m. EDT 26 August 2024**. Offerors are responsible for ensuring that their offers are received in accordance with the instructions stated herein. Late offers will not be considered.

### 1.3 Instruction for Offerors

All proposals must be submitted in one volume, consisting of:

- Signed Code of Ethics (Annex 1) and Statement of Integrity, Eligibility and Environmental and Social Responsibility (Annex 2) Completed Vendor Security Management Questionnaire for implementing agencies and all partners (Attachment 2, download here: <https://www.conservation.org/rfp-security-survey>)
- Technical proposal as described in section 1.3.1
- Cost proposal as described in section 1.3.2

This CFP does not obligate the Critical Ecosystem Partnership Fund to execute a contract nor does it commit the Critical Ecosystem Partnership Fund to pay any costs incurred in the preparation or submission of the proposals. Furthermore, the Critical Ecosystem Partnership Fund reserves the right to reject any and all offers if such action is considered to be in the best interest of the Critical Ecosystem Partnership Fund.

#### 1.3.1 Technical Proposal

The Technical Proposal should demonstrate a clear understanding of the work to be undertaken and the responsibilities of all parties involved. The offeror should include details on personnel, equipment, and contractors who will be used to carry out the required services. The technical proposal shall comprise the following parts:

- Part I: Technical Approach including:
  - Description of the recommended technical architecture and replacement process.
  - Clarification about whether the proposed solution can meet requirements described in Section 2, Scope of Work (SOW) and the requirements captured in Annex 3 and a detailed description of how the offeror intends to meet the requirements.
  - High-level description of content migration strategy.
  - Roles and responsibilities of implementation partner and delineation of roles between CEPF and implementor.
  - A Written Information Security Plan.
  - Confirmation of having an Incident Response Plan (IRP). If not publicly available, please provide the SOC 1 or SOC 2 reports to confirm the existence of an IRP.
  - This part shall be between 3 and 5 pages long, but may not exceed 5 pages.

Part II: Implementation methodology, including:

- Description of the high-level methodology and process.
- Estimated timeline for detailed project implementation activities.
- Roles and responsibilities of implementation partner.
- Roles and responsibilities of CEPF and estimated level of effort required.
- Standard artifacts that are generated as part of your methodology, such as use case templates, UAT test scripts, configuration/technical design documents.



- Standard meeting schedule.
- Description of administrator and end-user training approach.
- Part III: Implementation partner experience including:
  - Corporate capabilities and vendor experience, past performance, and 3 client references.  
This part shall be between 2 and 4 pages long, but may not exceed 4 pages. Please include descriptions of similar projects or assignments and at least three client references.
  - Staffing plan and personnel qualifications.  
Please propose how the project will be staffed including business hour availability. This part shall be between 2 and 5 pages long, but may not exceed 5 pages. CVs may be included in an annex to the technical proposal and will not count against the page limit. CVs must demonstrate: Experience and skills in Drupal and Craft CMS, development, project management, content migration, page content population through data feed, user experience and visual design.
  - Present examples of successful accessibility implementation in website development and tools used to accomplish it.
- Part IV: Transition Plan

### 1.3.2 Cost Proposal

**Estimated budget: US\$160,000 to US\$180,000.**

Offerors shall use the cost proposal template “Detailed Budget” attached in 1.3.3. The cost proposal must be valid for at least 90 days after submission to the Critical Ecosystem Partnership Fund. The cost proposal is used to determine which proposals are the most advantageous and serves as a basis of negotiation for award of a contract. The cost proposal must be all-inclusive of profit and fees. Additional costs cannot be included after award, and revisions to proposed costs may not be made after submission unless expressly requested by the Critical Ecosystem Partnership Fund should the offerors proposal be accepted.

Nevertheless, for the purpose of the proposal, Offerors must provide a detailed budget showing major expense line items. Offers must show unit prices, quantities, and total price. All items, services, etc. must be clearly labeled and included in the total offered price. All cost information must be expressed in US dollars. The cost shall also include a budget narrative that explains the basis for the estimate of every cost element or line item.

Supporting information must be provided in sufficient detail to allow for a complete analysis of each cost element or line item. The Critical Ecosystem Partnership Fund reserves the right to request additional cost information if the evaluation committee has concerns of the reasonableness or completeness of an offeror’s cost proposal.

If selected, Offeror shall use its best efforts to minimize the financing of any taxes on goods and services, or the importation, manufacture, procurement or supply thereof.  
If Offeror is eligible to apply for refunds on taxes paid, offeror shall do so. Any tax savings should be reflected in the total cost.

## Section 2. Scope of Work, Deliverables, and Deliverables Schedule

### 2.1. Scope of Work

This call for proposals will address the migration of cepf.net from Drupal 7 to Craft CMS, with all content, data, design, configuration, integrations, templates and custom modules. The Requirements and User Stories created under the preceding engagement for requirements discovery are included in **Annex 3**.

As part of the project, we expect the implementation partner to execute the following activities:

#### 1) **Detailed Analysis of Requirements and User Stories and Sprint/Release Plans**

The vendor will review existing requirements documentation and system configurations, interview key stakeholders and conduct a detailed analysis of migration and infrastructure requirements in order to validate and add any necessary detail to the requirements and user stories listed in **Annex 3**. Vendor will collaborate with CEPF to build use cases and acceptance criteria based on the user stories.

Vendor deliverables will include:

- Agreed upon scope in finalized user stories with use cases and acceptance criteria and contents of sprints/releases.
- Develop content model of CEPF.net currently managed in Drupal and map to a future state content model as it will be supported in Craft CMS.
- Technical architecture plan, including components, interfaces, file storage, CDN strategy, security and resilience.
- Detailed work plan and recommended sprint schedule, including dependencies, point and cost estimations and sprint methodology (duration of sprints, estimated vendor and client hours per sprint, cadence of meetings and releases).

#### 2) **Execution of Migration of cepf.net from Drupal 7 to Craft CMS, including System Installation, Configuration/Development, Testing of User Stories**

The vendor will design, develop, test and deliver system components, custom templates and modules based up on approved use cases, preferably using an agile methodology. The vendor will be responsible for unit and QA testing of stories prior to user acceptance testing.

#### 3) **Content Migration**

The vendor will migrate all site contents including pages, page components, legacy content and resources with associated metadata and tags. URLs should persist from

the current system to the new system. Where not possible, the vendor will provide a redirect strategy. The vendor will be responsible for defining a content migration plan, including plans for validation and cleanup support. The vendor should be clear in their response regarding any other services that are advised and/or included in the quotation to support content migration.

4) **Integration with Salesforce (grant database, also known as**

**ConservationGrants)** The vendor will replicate the Grantee Projects page feed functionality using the existing interface, which pulls data from Salesforce and stores it in a consumable public endpoint, performing proper adjustment and enhancement in order to be integrated to Craft CMS admin interfaces. The vendor will be responsible for testing that the function continues to create, update or delete pages when criteria is met to do so. The vendor will validate that all new pages and pages previously created by this function remain connected and appropriately check for updates or deletions. The vendor will be responsible for unit and QA tests of this functionality prior to user acceptance testing.

5) **Release Management, Deployment Planning and Post-Production Support**

The vendor will work with the cepf.net team to determine an appropriate release calendar and process to migrate functionality, including integrations, and content into the production environment. The vendor will be responsible for migrating code, customizations, content, system configurations and any security settings from a development environment to a full test environment for UAT. Once passing UAT, the vendor will complete the migration to the live site.

6) **Knowledge Repository, Technical Knowledge Transfer and Training**

The vendor will provide in-depth knowledge transfer to the CI technical team on system administration and maintenance tasks. The vendor will provide training to CEPF content administrators and content editors on system functionality.

7) **Project Management**

The vendor will lead the project management of the system and content migration and will be required to provide the following under this engagement:

- A project manager to oversee execution of the project.
- A project timeline that provides a list of activities, resources requirements, planned start and end dates, critical milestones, and dependencies for each functional area.
- A risk management process for identifying risks associated with the project timeline and deliverables.
- A collaboration tool and process, including meetings, centralized repository, process to facilitate the activities required for the project, and an area where bugs and issues can be logged and their resolution tracked.

Note: Conservation International prefers an agile project methodology for system installation, configuration/development, testing and implementation of user stories. As part of the project management deliverables, there will be a project management plan that will describe how the project will be managed including identification of sprint length and content, project team roles, and the process for managing stories from backlog through deployment. The technical proposal should include details of the vendor's implementation methodology and project management activities that are a standard part of the engagement.

## 8) **Technical Management**

The vendor will be required to provide the following technical requirements:

- Detailed backup and resilience plan.
- Detailed security and authentication plan.
- Detailed transition plan, which should consider the preservation or redirect of key URLs.

## 9) **Ongoing Support and Maintenance**

In addition to support immediately following the completion of deployment to the live site, this engagement requires ongoing support and maintenance for one year. The vendor will provide ongoing support and maintenance on cepf.net based upon priorities determined by the CEPF team. Anticipated volume of support required would be approximately 16 hours per month. Areas of support and maintenance include:

- CMS database and server management including regular system updates, security review, and back-up and disaster recovery support - mandatory
- Maintain centralized code repository, which will be provided by CEPF
- Implementation of new features and functionality
- Troubleshooting and repairing bugs as requested
- User experience design services
- New visual design services
- Training for CEPF staff on use of new features
- Project management services to implement updates to production
- Emergency support
- SLA

Time spent on necessary revisions to meet acceptance criteria may not be charged to CI unless authorized in writing by CI.

- b. Time is of the Essence. Service Provider shall perform the Services in strict compliance with the Delivery Schedule set forth in APPENDIX 1. Time is of the essence with respect to all aspects of this Agreement and the subject matter hereof.

5. Termination. Either party may terminate this Agreement at any time upon ten (10) days prior written notice. In such event, Service Provider shall provide to CI all deliverables (incl. all embodiments thereof) completed or partially completed up to the effective date of termination to CI in a format and medium specified by CI ,and CI shall pay a pro-rated fee for all Services provided by the Service Provider in good faith prior to the effective date of termination. Any payment effected by CI in excess of the pro-rated fee due on the effective date of termination shall be returned by the Service Provider immediately upon request by CI If CI terminates this Agreement due to a material breach by Service Provider or due to the Service Provider's failure to perform any of the Services to CI's satisfaction, CI may withhold payment for any such unsatisfactory Services until such Services are performed to CI's satisfaction.
6. Indemnification. Service Provider agrees to indemnify and hold harmless CI, any Funding Source, and their respective trustees, officers, directors, agents, and employees, including the cost of defense, for any claim made against them arising out of Service Provider's performance under this Agreement.
7. Relationship of CI and Service Provider.

- a. Service Provider is not an employee, agent or assign of CI for any purposes whatsoever. Accordingly, Service Provider shall be solely responsible for all matters relating to the employment of its personnel including, but not limited to, compliance with all applicable workers' compensation, unemployment compensation and social security laws and with all withholding and all other federal, state and local laws and regulations governing such matters. CI shall not provide Service Provider or its employees with any insurance or other benefits including, but not limited to, unemployment, medical, dental, worker's compensation and/or disability insurance.
  - b. Service Provider is performing the Services as an independent contractor of CI and not as an officer, employee, partner or agent of CI. Accordingly, Service Provider has no right or authority to assume or create any obligation of any kind or to make any representation or warranty, whether expressed or implied, on behalf of CI or to bind CI in any respect.
8. Government Officials and Employees. Service Provider hereby certifies that no assistance, payments or anything of value (monetary or non-monetary) shall be made, promised, offered to or accepted by any government employee or official (a) in contravention of any U.S. or other applicable law or regulation including, but not limited to, the U.S. Foreign Corrupt Practices Act; (b) without the express consent of the government for which the employee or official works; and (c) that is not reasonable, *bona fide*, and directly related to the activities funded under this Agreement. It is Service Provider's responsibility to ensure compliance with this clause, and to maintain and provide at CI's request, documentation demonstrating such compliance. Service Provider hereby certifies that no payments or other form of assistance shall be made to or accepted by any government employee or official (x) to influence any official government act or decision; (y) to induce any government employee or official to do or omit to do any act in violation of his or her lawful duty; or (z) to obtain or retain business for, or direct business to any individual or entity. If Service Provider is a government employee or official, Service Provider shall recuse him/herself from any governmental act or decision affecting CI and shall not influence any governmental act or decision affecting CI. Under no circumstances shall any payments or anything of value be given, made, promised or offered to any U.S. Federal, State or local employee or official.
9. Confidential Matters and Proprietary Information. During the course of this Agreement, either party may acquire confidential information or trade secrets of the other ("Confidential Information"). Each party agrees to keep all such Confidential Information in a secure place, and further agrees not to publish, communicate, divulge, use, or disclose, directly or indirectly, for his own benefit or for the benefit of another, either during or after performance of this



Agreement, any of the Confidential Information, except as may be required by law or this Agreement. Upon termination or expiration of this Agreement, each party shall deliver all Confidential Information produced or acquired during the performance of this Agreement and all copies thereof to the other. This obligation of confidence shall not apply with respect to information that is (a) available to the receiving party from third parties on an unrestricted basis; (b) independently developed by the receiving party; or (c) disclosed by the other party to others on an unrestricted basis.

10. Intellectual Property

CI All work product created, prepared, procured, generated or produced by Service Provider under this Agreement and delivered to CI including, but not limited to, raw or processed data, articles, reports, drawings, computer data bases, and all other memoranda (collectively, "Works"), shall belong solely and exclusively to CI. All Works shall be deemed "works made for hire" within the meaning of U.S. copyright law, and CI shall be deemed the author of the Works. If for any reason, any Work is not deemed a "work made for hire," or all rights in and to any Work are deemed not to vest in CI, Service Provider hereby irrevocably assigns and transfers any rights it may retain in and to the Works to CI and waives all its rights, title and interest in and to the Works, including moral rights. Upon CI's request and at its expense, Service Provider agrees to cooperate with and assist CI in perfecting its rights in and to the Works, including executing appropriate documents.

CI will have the sole right to copyright the Works, except that Service Provider grants to CI a nonexclusive, irrevocable royalty-free license to reproduce, translate, publish, use and dispose of, and to authorize others to so do, all copyrighted or copyrightable material not first produced or prepared by Service Provider in the performance of this Agreement, but which is incorporated in the Works, provided that such license shall be only to the extent that the Service Provider now has, or prior to completion of the Agreement may acquire, the right to grant such license without becoming liable to pay compensation to others solely because of such grant. To the extent that the Works contain any material to which Service Provider does not have the right to grant such license, Service Provider will assume responsibility for obtaining all necessary rights for use, reproduction, translation, publication and disposition of that material by CI

CI will have the sole right to copyright such Works, except that Service Provider grants to CI a nonexclusive, irrevocable royalty-free license to reproduce, translate, publish, use and dispose of, and to authorize others to so do, all copyrighted or copyrightable material not first produced or prepared by Service Provider in the performance of this Agreement, but which is incorporated in the Works, provided that such license shall be only to the extent that the Service Provider now has, or prior to completion of the Agreement may acquire, the right to grant such license without becoming

liable to pay compensation to others solely because of such grant. To the extent that the Works contain any material to which Service Provider does not have the right to grant such license, Service Provider will assume responsibility for obtaining all necessary rights for use, reproduction, translation, publication and disposition of that material by CI.

11. Security and Safety. Service Provider agrees that s/he has read, understands and shall comply with any applicable security regulations provided by CI, and acknowledges that Service Provider shall be solely responsible for Service Provider's own safety and physical property or equipment during the performance of this Agreement.
12. Travel. Service Provider shall be solely responsible for any travel arrangements, travel insurance, and all arrangements for visas, passports or immunizations.
13. Choice of Law; Arbitration. This Agreement shall be construed and enforced in accordance with the laws of the District of Columbia, USA, applicable to contracts fully executed and performed therein and without giving effect to its conflict of laws principles. Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, shall be settled by arbitration before a single arbitrator in Washington, DC, under the rules of the American Arbitration Association in effect at the time of commencement of the arbitration, and the parties agree that judgment upon the award rendered by the arbitrator shall be final, binding and may be entered in any court having jurisdiction thereof.
14. Compliance With Law; CI Code of Ethics. Service Provider will perform the Services in compliance with (i) the U.S. Foreign Corrupt Practices Act and Office of Foreign Asset Control regulations, as well as (ii) all laws and regulations of the country in which the Services are performed (including, but not limited to, such relating to bribery, corruption, terrorism financing and equal employment opportunity, as well as all the generally accepted standards applicable to such work), as if such aforementioned laws and regulations directly reached the activities of the Service Provider. Further, Service Provider agrees to perform all Services and to conduct all activities related thereto in accordance with CI's Code of Ethics, a copy of which is attached hereto as Appendix 2 and incorporated by reference.
15. Service Provider's Anti-Terrorism Representation And Warranty. Service Provider is hereby notified that U.S. Executive Orders, U.S. and other international law prohibit transactions with, and the provision of resources and support to, individuals and organizations associated with terrorism. Service Provider, therefore, represents and warrants that Service Provider has not provided, and will take all reasonable steps to ensure that Service Provider does not and will not knowingly provide, material support or resources to any individual or entity that commits, attempts to commit, advocates, facilitates,

or participates in terrorist acts, or has committed, attempted to commit, facilitate, or participated in terrorist acts, and is compliant with all other applicable provisions of such U.S. Executive Orders and U.S. and other international law. Service Provider shall ensure that it makes no payment with funds provided hereunder to persons or entities listed on any financial sanction list maintained by the United Nations, European Union, France and the United States of America or other jurisdiction where Services are carried out, (ii) for any payment to purchase, supply, finance any supplies, services or sectors which are subject to an embargo by the United Nations, the European Union, France, United States or other jurisdiction where Services are carried out.

16. Counterparts And Facsimile Signatures.

- a. Each party agrees that the other party may rely on a facsimile copy of the signature of a duly authorized signatory and that upon the exchange of such facsimile signatures, electronically or otherwise, this Agreement shall be binding between the parties whether or not hard copies of this Agreement are ever exchanged between them.
- b. This Agreement may be signed in one or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument even though all the parties are not signatories to the original or the same counterpart.

17. Severability. In the event that any one or more of the provisions contained herein shall, for any reason, be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provisions of this Agreement, but this Agreement shall be construed as if such invalid, illegal or unenforceable provisions had never been contained herein, unless the deletion of such provision or provisions would result in such a material change so as to cause completion of the transactions contemplated herein to be unreasonable.

18. No Third-Party Beneficiaries. Except as expressly set forth herein, neither party intends that this Agreement shall benefit or create any right or cause of action in or on behalf of any person or entity other than the Service Provider and CI.

19. Non-Assignment. This Agreement shall not be transferred or assigned by Service Provider without prior written consent of CI.

20. Grievance Mechanism. Service Provider is responsible for the implementation and monitoring of the Code of Ethics in (Attachment 2). Service Provider shall immediately report any allegations or suspicions of violations of the Code of Ethics or Agreement terms related to corruption, fraud or anti-competitive practice; fund from illicit origin or other Project-related grievances. Grievances will be addressed in accordance with the CI's established grievance mechanism. Service Provider shall ensure that all of its

employees, sub-contractors and sub-grantees are informed of CI's grievance mechanism at [www.ci.ethicspoint.com](http://www.ci.ethicspoint.com) or via phone to a local dial-in number displayed at [www.ciethicspoint.com](http://www.ciethicspoint.com) ("CI Ethics Hotline"). CI will promptly investigate any grievances submitted to the CI Ethics Hotline. CI will treat complaints as confidential to the extent possible, with the understanding that confidentiality may not be maintained where identification is required by law or to enable CI or law enforcement to conduct an adequate investigation. Service Provider shall not retaliate against any employee or other person who submit such grievances in good faith. Retaliation is subject to termination of this Agreement and other sanctions, including ineligibility of Service Provider to submit future proposals to CI for CEPF-related activities.

21. Waiver. Either party may specifically waive any rights under this Agreement by the other party, but no such waiver shall be deemed effective unless in writing, signed by the waiving party, and specifically designating the rights waived. No waiver shall constitute a continuing waiver of similar or other rights.
22. Entire Agreement; Amendments. This Agreement supersedes all prior oral or written agreements between the parties and constitutes the entire Agreement between the parties. Unless indicated otherwise herein, this Agreement may not be amended, supplemented, or modified in any respect except by written agreement signed by both parties.
23. Notices. Notice under this Agreement shall be deemed to have been sufficiently given either when served personally or when sent by first-class registered mail addressed to the parties at the addresses set forth below. CI shall not be liable for, nor shall Service Provider be liable to perform, services or expenses incurred after the receipt of notice or termination.

24. Acts of corruption, fraud or anti-competitive practice; fund from illicit origin.

- a. Act of Corruption means any of the following:
- (1) the act of promising, offering or giving, directly or indirectly, to a Public Official or to any person who directs or works, in any capacity, for a private sector entity, an undue advantage of any nature, for the relevant person himself or herself or for another person or entity, in order that this person acts or refrains from acting in breach of his or her legal, contractual or professional obligations and, having for effect to influence his or her own actions or those of another person or entity; or
  - (2) the act of a Public Official or any person who directs or works, in any capacity, for a private sector entity, soliciting or accepting, directly or indirectly, an undue advantage of any nature, for the relevant person himself or herself or for another person or entity, in order that this person acts or refrains from acting in breach of his or her legal, contractual or professional obligations and, having for effect to influence his or her own actions or those of another person or entity.
- b. Anti-Competitive Practices means:
- (1) any concerted or implicit action having as its object and/or as its effects to impede, restrict or distort fair competition in a market, including without limitation when it tends to: (i) limit market access or the free exercise of competition by other companies; (ii) prevent price setting by the free play of markets by artificially favoring the increase or decrease of such prices; (iii) limit or control any production, markets, investment or technical progress; or (iv) share out markets or sources of supply;
  - (2) any abuse by a company or group of companies of a dominant position within a domestic market or in a substantial part thereof; or
  - (3) any bid or predatory pricing having as its object and/or its effect to eliminate from a market, or to prevent a company or one of its products from accessing the market.
- c. Fraud means any unfair practice (acts or omissions) deliberately intended to mislead others, to intentionally conceal elements there from, or to betray or vitiate his/her consent, to circumvent any legal or regulatory requirements and/or to violate internal rules and procedures of the Beneficiary or a third party in order to obtain an illegitimate benefit.

- d. Fraud against the Financial Interests of the European Community means: any intentional act or omission intended to damage the European Union budget and involving (i) the use or presentation of false, inaccurate or incomplete statements or documents, which has as its effect the misappropriation or wrongful retention of funds or in any illegal reduction in resources of the general budget of the European Union; (ii) the non-disclosure of information with the same effect; and (iii) misappropriation of such funds for purposes other than those for which such funds were originally granted.
  - e. Illicit Origin means funds obtained through:
    - (1) the commission of any designated categories of offences under [FATF 40](https://www.fatf-gafi.org/media/fatf/documents/FATF%20Standards%20-%2040%20Recommendations%20rc.pdf) (<https://www.fatf-gafi.org/media/fatf/documents/FATF%20Standards%20-%2040%20Recommendations%20rc.pdf>)
    - (2) any Act of Corruption; or
    - (3) any Fraud against the Financial Interests of the European Community, if or when applicable.
  - f. The Service Provider shall (i) use its best efforts ensure that its equity and assets will not come from Illicit Origin the Services, (ii) ensure that the Services shall not give rise to any Act of Corruption, Fraud or Anti-Competitive Practice, (iii) inform CI with immediately upon becoming aware of or suspecting any Act of Corruption, Fraud or Anti-Competitive Practice, (iv) take all necessary measures to remedy the situation in a manner satisfactory to CI and the Funding Sources and within the time period determined by CI and/or the Funding Sources, and notify CI immediately of any information which leads to suspect the Illicit Origin of funds invested in the Services.
25. Instructions, Inspections and Audits. The Service Provider shall permit CI, the Funding Sources, or any party designated by CI or the Funding Sources, to inspect the site and/or the accounts and records of the Service Provider relating to the performance of this Agreement, and to have such accounts and records audited by auditors appointed by CI or the Funding Sources, if so requested by CI or the Funding Sources.

## ANNEX 3

### Requirements Delivered by Previous Consulting Engagement

#### Background

The Critical Ecosystems Partnership Fund site, *cepf.net*, which provides project information and resources to donors and grantees, is running on Drupal 7. The infrastructure is outdated and the site's content and code have become difficult to maintain. An update is needed so that the site can continue to be a resource around the world and can be maintained efficiently going forward with minimal staffing.

#### Overview

The goal of this project is to migrate all content, functionality, integrations, and design of the *cepf.net* site to an updated content management system. Global availability is required, so the infrastructure must support scalability and be optimized for fast edge delivery. The content management system must support multiple languages for both content and assets. The chosen provider must include AWS-based infrastructure setup and CMS training in their proposal, and must itemize any anticipated software licensing fees (if any). Conservation International/CEPF's goals for the new CMS include a content management system that is easy for administrators to maintain; has the ability to integrate with other systems; is actively supported and widely used; and supports a redundant hosting infrastructure.

#### Disclaimer

1. The list of requirements below represents our interpretation of the current state of CEPF.net website and what it takes to migrate for a modern CMS platform such as Craft CMS, based on interviews with CEPF stakeholders as well as a navigation discovery. Improvements, adjustments and re-shapes may be necessary and encouraged as we migrate from different platforms, following CEPF vision and goals, as well as respecting Craft's and contents limitations, ensuring to make use of the new CMS full potential.
2. A full content modeling session must be estimated in the proposal.
3. Some use cases could have been missed or underappreciated during the interviews or navigation discovery through the website. In any case, the items below represent a broader view of the project size and scope and are sufficient as a background for high-level cost estimates.

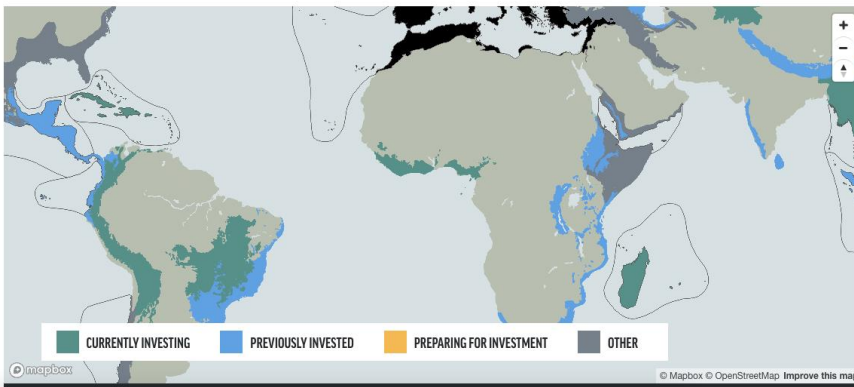

## WHAT IS A BIODIVERSITY HOTSPOT?

There are currently **36 recognized biodiversity hotspots**. These are Earth's most biologically rich—yet threatened—terrestrial regions.

To qualify as a biodiversity hotspot, an area must meet two strict criteria:

- Contain at least 1,500 species of vascular plants found nowhere else on Earth (known as "endemic" species).
- Have lost at least 70 percent of its primary native vegetation.

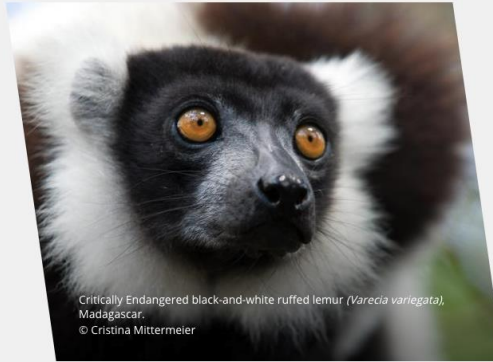

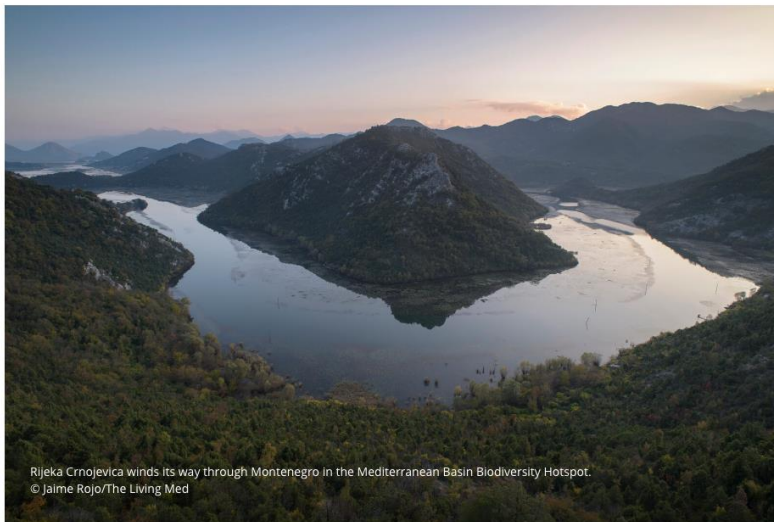

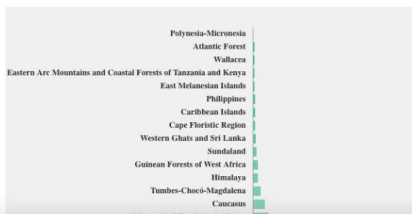

## WHAT IS THE CONVENTION ON BIOLOGICAL DIVERSITY?

The U.N. *Convention on Biological Diversity (CBD)* is an international treaty—signed by 196 parties—supporting the conservation of the variety of life on Earth.

## Back to the Madagascar Wild

CEPF grantee works toward safe return of hundreds of tortoises to their natural habitat

Through two record seizures in 2018, Malagasy authorities rescued thousands of live radiated tortoises (*Astrochelys radiata*) that were likely headed for the illegal wildlife trade—including nearly 10,000 found crammed into a house in Toliara.

The law enforcement operations were important mileposts in the response to the devastating impacts of poaching, but they also raised important questions: what to do with so many of the Critically Endangered species and under which conditions could they be released into their natural habitat?

More than 9,000 confiscated tortoises were transferred to Tananan'ny sokake, or Le Village des Tortues (the Village of Tortoises), a wildlife rehabilitation facility located north of Toliara in the village of Ifaty, co-managed by French organization Station d'Observation et de Protection des Tortues et de leurs Milieux (SOPTOM) and Malagasy organization Association de Sauvegarde de l'Environnement (ASE).

Many of the tortoises were then moved to other rehabilitation centers, and several hundred had to be euthanized due to poor health, but 2,000 stayed. Le Village des Tortues was already home to a large number of radiated tortoises as well as another species threatened by the illegal wildlife trade—spider tortoise (*Pyxis arachnoides*). The sudden influx of such a large number of tortoises stretched the facility's resources and space. A plan was needed for returning

# ABOUT

Biodiversity—the rich array of life on Earth—is fundamental to human survival, but under tremendous and growing threat. The Critical Ecosystem Partnership Fund (CEPF) was founded in 2000 to address this challenge by empowering civil society in developing countries and transitional economies to protect the world's biodiversity hotspots, which are some of Earth's most biologically rich yet threatened terrestrial ecosystems.



Through **grants totaling more than US\$277 million and technical assistance to over 2,600 civil society organizations and individuals**, we have taken action to conserve more than **1,000 species in the IUCN Red List of Threatened Species**, and strengthened the management and protection of **51.6 million hectares of Key Biodiversity Areas**. Our grantees have also contributed to the establishment of **16.2 million hectares of new protected areas**, and the **improved management of 10.5 million hectares of production landscape**—areas where agriculture, forestry or natural product harvesting occur. And **more than 4,900 communities** in the biodiversity hotspots have benefited directly from CEPF-funded projects through improved access to clean water, improved land tenure and increased representation in decision-making processes.

## WHAT MAKES US UNIQUE

By supporting development of conservation strategies for the biodiversity hotspots that are driven by local input, and providing grants to civil society—nongovernmental, private sector and academic organizations—to implement those strategies, CEPF seeks to protect biodiversity, build long-term local conservation leadership and nurture sustainable development.

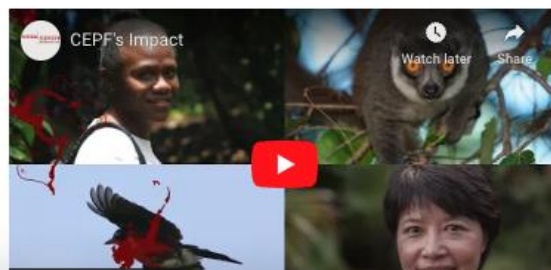
These strategies also are designed to be valuable to other entities working to conserve the hotspots, and often lead to collaboration and coordination with other organizations and governments.

CEPF's investments are especially important because the hotspots are home to more than 1 billion people, millions of whom are impoverished and highly dependent on nature for survival.

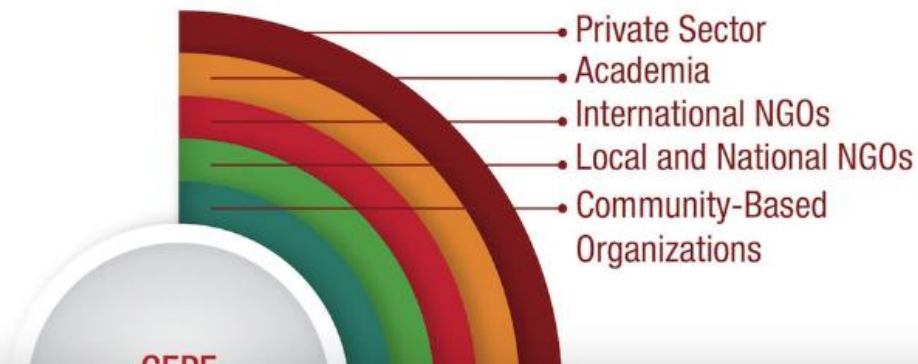

## OUR TEAM

- **Grantees:** Our grantees include local, national and international nongovernmental organizations, community-based organizations, private sector and academic entities.
- **Global donor organizations:** CEPF has six global donors who provide not only funding, but also governance and technical assistance.
- **Regional implementation teams:** CEPF's regional implementation teams work in the biodiversity hotspots with CEPF's grantees, helping to build local capacity and implement CEPF's conservation strategy.

The idea that would become the Critical Ecosystem Partnership Fund was hatched in 1996. "We agreed that the [World] Bank could play a bigger role in protecting biodiversity and building civil society," Seligmann recalled later. "So Jim asked me to put something down on paper about how that could work. I went back to D.C. and wrote something up." KBAs are sites that contribute significantly to the global persistence of biodiversity. CEPF uses KBAs as the lens for selecting geographic priorities for conserving species.

To qualify as “strengthened,” an area must have benefited from one or more of a range of actions that contribute to improved management, such as increased patrolling, invasive species control or eradication or introduction of sustainable agricultural/fisheries practices. CEPF grantees also have contributed to the creation of **16.2 million hectares of protected areas.**

## Back to the Madagascar Wild

CEPF grantee works toward safe return of hundreds of tortoises to their natural habitat

Through two record seizures in 2018, Malagasy authorities rescued thousands of live radiated tortoises (*Astrochelys radiata*) that were likely headed for the illegal wildlife trade—including nearly 10,000 found crammed into a house in Toliara.

The law enforcement operations were important mileposts in the response to the devastating impacts of poaching, but they also raised important questions: what to do with so many of the Critically Endangered species and under which conditions could they be released into their natural habitat?
