Project Details

8. Summary of the sub-project:

This project is designed to address the need for enhanced management of the Blue and John Crow Mountains National Park to better secure the conservation of its unique forest and species. This will be addressed through 4 main components:

- 1) Updating the Blue and John Crow Mountains National Park Management Plan for improved biodiversity conservation activities.
- 2) Enhancing Biodiversity Monitoring and Research Capacity for Strategic Conservation Management at JCDT.
- 3) Institutional strengthening and capacity building of JCDT to improve programmatic monitoring and evaluation.
- 4) Implement conservation action plan for the Wild Pine Seargent (Jamaican Blackbird) in the Blue Mountains KBA.

9. Overview of project components relating to community health and safety:

The updating of the JCDT Management Plan will be done with consultation from community stakeholders as we take a co-management approach to conservation of the Blue and John Crow Mountains National Park. Conservation and threat reduction activities associated with this project will be in accordance with existing environmental legislation which prevents certain kinds of land use within the National Park. This includes farming and any kind of land clearing. This will be communicated to residents who live in communities adjacent to the National Park. Park Rangers will also issue warnings if they encounter breaches of the legislation. They will also involve government enforcement stakeholders to take action.

We will have meetings with residents as we consult with them and seek to educate them on conservation issues.

Measures to avoid risk of COVID-19

JCDT will act in accordance to the Government of Jamaica guidelines and policies regarding transmission of COVID-19. The organisation is prepared to act and adjust activities according to the level of risk as indicated by the Government. Once an outbreak has been reported and the risk is at medium, all meetings and in person gatherings will require all participants to wear masks, sanitize hands on entry and maintain appropriate distance from each other (3 feet). As risk increases, meetings may move to virtual rather than in person. Some activities may have to be rescheduled based on Government mandates on movement. Most activities however can be carried out virtually.

Any other relevant guidance from the World Bank as outlined in the technical note, "Public Consultations and Stakeholder Engagement in WB-supported operations when there are constraints on conducting public meetings" (March 20, 2020)¹ will be followed, as relevant and appropriate.

Emergency preparedness and response plan

JCDT will act in accordance to the Government of Jamaica guidelines and policies regarding natural disasters. In particular, we will observe guidance from the Meteorological Office as well as the Office of Disaster Preparedness and Emergency Management on the risk of hurricanes and storms in particular. Field activities will be rescheduled in the event of any storm, flooding or hurricane advisory.

Measures to mitigate risks relating to security personnel

National Park Rangers are trained in environmental monitoring, community outreach and law enforcement. Rangers are unarmed to limit the risk of violent confrontation. Rangers limit their enforcement activities to verbal and written warnings as well as reports to local police and other government enforcement partners such as the Forestry Department. Rangers are trained to involve local law enforcement (police, government environmental officers) if enforcement action is required. They are trained to get to escalate or get into physical confrontations.

Implementation of the Plan

13. Monitoring and evaluation:

JCDT will monitor and evaluate the effectiveness of the measures listed above through regular communication and coordination with all its staff, consultants, the CEPF Secretariat, RIT and key project stakeholders. JCDT will report on its efforts and results in bi-annual reports to the CEPF Secretariat as well as in RIT site visits and CEPF supervision missions.

Primary monitoring responsibility will fall to the Projects Officer, who will complete quarterly reports based on a basic reporting form, which JCDT will develop. The monthly report will include data collected about the application of the measures above, report any issues and concerns, make recommendations, as needed and identify any gaps that may need to be filled.
