Under leadership of IFCE, the 3rd NGO Forum on International Environmental Cooperation in China was held in Beijing in November 18-20, 2003. A total of 426 people representing 35 international NGOs and 149 Chinese NGOs attended the Forum and the training workshops. Information and experience were shared and new partnerships were formed. Through NGO management training workshop, participants gained skills for advanced management. At the Forum, sub-groups such as college-based green group, river-interested group, etc. had an opportunity to network and communicate for further cooperation.

A workshop for capacity assessment of green NGOs in southwestern China was conducted in the Forum. The needs of the critical skills for strategic organizational development, management, and other leadership skills of the green NGOs were evaluated. A report on green NGOs capability and training needs in southwestern China was developed. Recommendation on future training were developed.

In our original proposal, further research and case studies would be conducted in order to understand better the overall development environment for NGOs in southwest China. Without this research and study, we won't be able to assess CEPF's market niche in order to develop a full capacity building plan. Since training is only one part of the capacity building, with a proper plan and specific targets, CEPF could do more in supporting NGO-government partnerships, policy formation and legislative actions. These are also crucial for NGOs to grow in the region.
